Celebration of the 350th Anniversary of the Royal Mathematical School (RMS) at the British Ambassador's Residence (Washington, DC, Nov 1 2023)



The British Embassy celebrated this significant milestone in the history of the school, for two reasons. First, is the strong probability that many of the navigators on the ships bringing settlers to the New World had been trained at the RMS – Between 1673 and 1887 just over 2,000 boys were trained at the RMS school. Second, is that Professor Michael Mainelli, the first ever US-born Lord Mayor of London, chose to highlight the Royal Mathematical School in his mayoralty through the creation of the Lord Mayor's RMS Scholarship programme. A total of 300 guests attended, including Old Blues, The Head Teacher, Senior Grecian and other school representatives.



Transatlantic Exchange Dinner – Baltimore, April 2024

The annual Transatlantic Exchange dinner was hosted in April by FCH Board President Sally O'Brien (5s 70-77) at the Mount Vernon Club in Baltimore. About 30 guests (including Old Blues and parents, faculty and exchange students from Gilman and Bryn Mawr, our two exchange schools in Baltimore) came together for a traditional CH dinner complete with toasts and a rousing cheer of Housey!

We heard from CH exchange pupils Tanitoluwa Odusina and Rebecca Brown who had jumped right into life at an American high school; having already been shown the sights of New York and Washington DC by their host families.

Started in 2005, the Transatlantic Exchange Program provides opportunities for a CH boy and girl to attend the Gilman and Bryn Mawr Schools in Baltimore for a month over the CH Easter break. They then host a Gilman boy and Bryn Mawr girl at Housey in the summer. To date some 40 CH pupils have enjoyed the opportunity to experience school in the US and many have gone on to attend university in the US as a direct result of that early exposure. Indeed, our very first CH exchange student (and former FCH board member) Mark Laichena (MaA 00-07) was a Moorehead Scholar at the University of North Carolina.

It was Lance who adopted the phrase "friend-raising" and made every effort to know just about every Old Blue located in the United States.

Jack and Lance were the first of many Old Blue volunteers who have served on the board of FCH. Thanks to their initiatives, we have enjoyed a Founder's Day Dinner in the USA just about every year since 2001 (pandemic excepted) and provided massive support to CH, most recently through our Blue Fund Bursaries, that have sent three pupils to CH fully funded. Sadly, we lost both Jack and Lance in recent years. 
As I look to the year ahead, I hope, given FCH's increased focus on

Treasurer's Report by Keith Worker

FCH provides Old Blues and others residing in the US a tax-efficient way to support Christ's Hospital. As a tax-exempt public charity under sections 501(c)3 and 170(b)(1) (A)(vi) of the Internal Revenue Code, all donations to FCH are tax-deductible to the extent provided by law.

Income from donations in 2023 was \$231,745 (vs \$458,901 in 2022 - which included a very generous one-time donation from an Old Blue. In 2023 there were 41 individual donors. These included significant donations from Jack Doyle (Deceased), Anthony Furnivall, Andrew Fyfe, George Matcham, Roger Moseley, Lance Reynolds (Legacy) and Roger Thomas.

Disbursements to Christ's Hospital in 2023 totaled \$445,643 (vs \$187,000 in 2022).

FCH's account balances on January 1, 2023 were \$361,475. The closing account balances on December 31, 2023 totalled \$142,712.

Expenses were \$5,080 (vs \$5,260 in 2022). Expenses as a % of income continued to be low (2.2%).

As required under U.S. law, while the Board of Directors will always consider the expressed preferences of its donors when making grant decisions, the Board must retain discretion and control over the use of all contributions it receives. FCH has very low operating costs and its volunteer Board directly contributes to the organization's operating expenses. Checks written and mailed to FCH in the latter half of December, although tax deductible to the donor, may not clear until the following year. If these amounts are substantial the grants shown on our Federal Return (Form 990) may be less than the grants actually made from the donations received.
